# Art at the Liechtenstein Palaces

The Liechtenstein City Palace, considered to be the first major building of the High Baroque age in Vienna, has recently been restored to its former glory following extensive renovation work. Its Baroque stucco ceilings blend with opulent Rococo Revival interiors, original furnishings and exquisite parquet flooring by Michael Thonet to form a harmonious whole, revealing insights into the aristocratic life of bygone epochs.

The Liechtenstein Garden Palace is home to one of the world's largest and most important private art collections. Dating back to the 17th century, the Princely Collections are rooted in the Baroque ideal of princely patronage of the arts. For generations, the House of Liechtenstein has consistently nurtured this ideal, systematically adding to the holdings.

We invite you to view paintings, porcelain and furniture from one of the most productive and autonomous periods in the history of Viennese art, Biedermeier and Classicism. These include masterpieces by Friedrich von Amerling, Friedrich Gauermann and Ferdinand Georg Waldmüller and are the earliest examples of furnishings in the Neo-Rococo style in Vienna.

### **H.S.H. Prince Philipp von und zu Liechtenstein** Honorary Chairman, LGT

H.S.H. Prince Philipp von und zu Liechtenstein is the Honorary Chairman of LGT.

H.S.H. Prince Philipp started his career with the London-based Hambros Bank & Trust Limited, before moving to Banque Rothschild in Paris which specialises in asset management. From 1979 to 1981, he was Chairman of the Supervisory Board of Liechtensteinische Landesbank in Vaduz. From 1981, H.S.H. Prince Philipp served as a member and then Chairman of the Board of Directors of LGT Bank in Liechtenstein, Liechtenstein Global Trust and LGT Capital Management. From 2001 to 2020, he was Chairman of LGT, leading the Group's international growth and developments.

H.S.H. Prince Philipp is a founding member of the European Centre of Austrian Economics Foundation (ECAEF) and Governor of the European Financial Forum in London. He studied history and social sciences in Bonn and Basel.



## H.S.H. Prince Max von und zu Liechtenstein

H.S.H. Prince Max von und zu Liechtenstein has been the CEO of LGT Group since 2006 and was appointed to the role of Chairman of LGT Group in 2021. H.S.H. Prince Max is also the founder of Lightrock and LGT Venture Philanthropy as well as Chairman of Lightrock and a member of the Foundation Board of LGT Venture Philanthropy.
