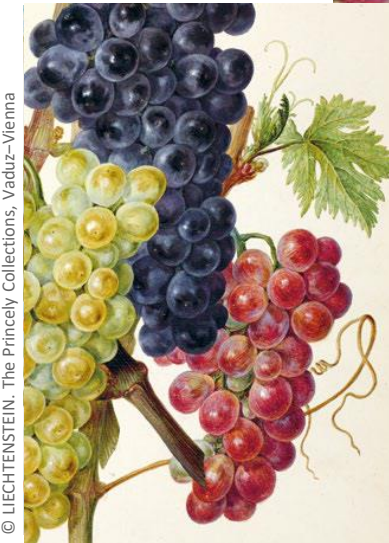

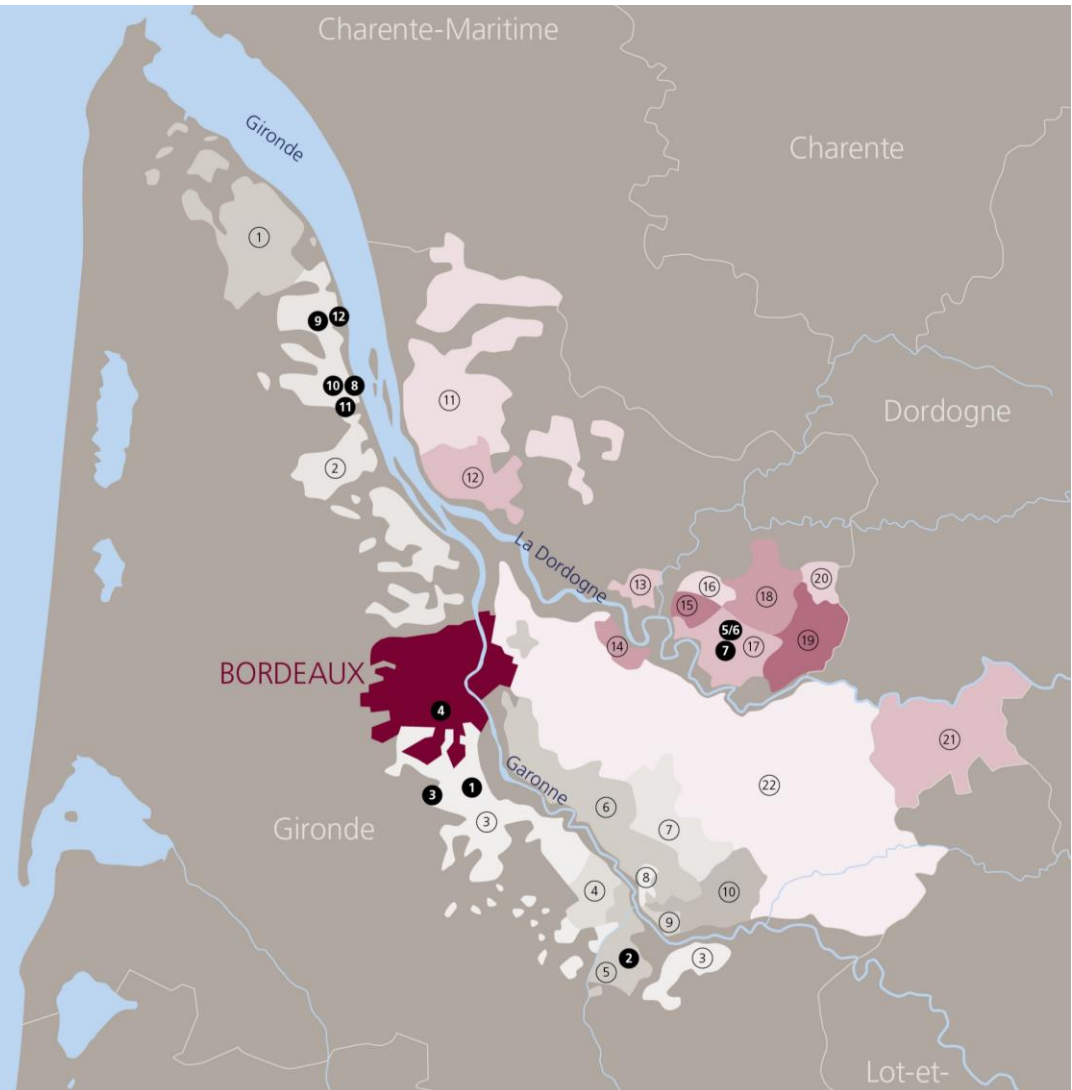

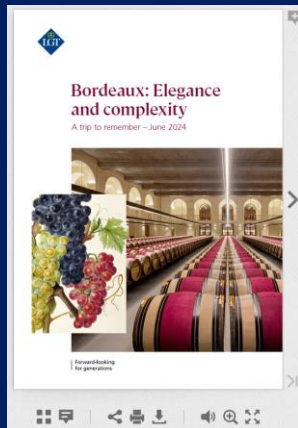

2. Ets Martin
